Before placing an order we encourage our customers to read our Terms and Conditions, All orders we accept are subject to our terms and conditions unless otherwise specifically agreed to in writing by Electronic Integration Inc. herein referred to as EII. These terms and conditions supersede all others – even if yours say they supersede ours.

All Quotes are valid for 30 days. This quotation is subject to **change** if the information upon which this quotation was based is found to be inaccurate or incomplete.

We reserve the right to change price and delivery anytime.

DELIVERY TERMS

- All components and boards must be received prior to beginning the assembly process. Anything received after 12p.m. will be considered the next day. The clock does not start until we have a complete and accurate kit as well as signed confirmation order from the customer. Our terms are F.O.B. Feasterville, Pa 19053. All Blanket purchase orders will be shipped within the year from purchase order date unless otherwise specified.
- We will schedule out shipments or blanket orders over a 12-month period; however, the order will be manufactured at the discretion of EII to maximize production capabilities and cost efficiencies. Pricing can be guaranteed for 3 months only. If for any reason this order is cancelled at any time prior to the final scheduled shipment, any or all of the completed order will be subject to a cancellation fee which may be up to 100% depending on the manufacturing status at the time of cancellation. Customer is liable for all completed product quantities

PAYMENT

- Your first order must be pre-paid via a credit card or COD. We accept Visa, MasterCard and Amex. There will be additional charges for processing credit cards. We charge your card at the time your order is placed.
- Applications for credit terms are subject to our approval and will be considered based on your order history and our evaluation of your credit application. The application process typically takes between a few days and a few weeks, depending on how accessible your references and financial information is.
- Payment terms on all sales and quotations are Net 30 days from the date of invoice. Any invoice not paid by maturity date of net thirty days from the date of invoice Buyer shall pay interest from maturity date to date of payment at the annual percentage rate of 18% (or such lower rate as may be maximum allowable by law) together with Seller's costs of collection (including reasonable attorney's fees) EII reserves the right to modify terms prior to shipment, require payment in advance, or delay or cancel any shipment or order by reason of customer's credit worthiness or should customer fail to make payment when due.
- Canceled orders: You are liable for the cost of parts that have been purchased or expenses that have been incurred prior to canceling an order. Cancellations will only be agreed to by the Company on condition that all cost and expenses incurred by the Company up to the time of cancellation and all loss of profits and other loss or damage resulting to the Company by reason of such cancellation will be paid forthwith by the Customer to the Company (Electronic Integration Inc). Buyer will also pay EII collection including reasonable attorney fees .

SHIPPING

We use UPS as our standard carrier and if you would like to request other shipping arrangements or charge your shipping account, let our sales rep know prior to the start of your assembly job. Shipment terms are FOB Origin, unless otherwise quoted or agreed upon by both parties. EII shall not be liable for damage or mishandling by the freight forwarder in the event of damage to assets.

International destinations will incur additional shipping and handling fees based on the size of the order as well as import fees.

EII'S LIMITED 90 DAYS WARRANTY AND EII'S LIABILITY

THIS LIMITED WARRANTY IS GOVERNED BY AND CONSTRUED UNDER THE LAWS OF STATE OF PENNSYLVANIA.

EII warrants each assembly for workmanship and material under normal use for a period of 90 days from the date of shipment. If a defect arises and a valid claim is received within the warranted period and confirmed by EII to be non conforming to order specifications and or applicable quality and acceptability standards, EII will either replace the part at no extra charge or issue a credit equal to the original purchase price of the unit. The replacement part belongs to the customer and the returned part is now EII's property. If a refund is given the defective part is now EII's property.
